**ATTENTION AREA RESIDENTS: DYKE ROAD EYED FOR THIRD MUNICIPAL PROPERTY ACQUISITION**

**DO YOU WANT MORE TRAFFIC ON DYKE ROAD COMING INTO STRONGS NECK?**

**THAT MAY HAPPEN IF THE TOWN OF BROOKHAVEN BUYS 18 DYKE ROAD AS THE 'CULPER SPY RING FARM HOUSE' (See Timeline below). WHAT DOES THE TOWN INTEND TO DO WITH THIS PROPERTY?**

**HERE IS WHAT WE KNOW SO FAR:**

- TOWN OF BROOKHAVEN INTENDS TO PURCHASE A SINGLE-FAMILY RESIDENCE AT 18 DYKE ROAD, SETAUKET WHICH IS CURRENTLY ON THE MARKET WITH PUBLIC FUNDS AND WITHOUT SUBMITTING AN ENVIRONMENTAL IMPACT STATEMENT.
- THIS RESIDENCE IS IDENTIFIED ON THE SUFFOLK COUNTY TAX MAP AS: SCTM NO. 0200-062.00-2.00-005.000. IT IS IDENTIFIED BY TOB AS "CULPER SPY RING FARM HOUSE IN SETAUKET"
- 18 DYKE ROAD, SETAUKET IS A RANCH, BUILT IN 1969 AND, NOW ZONED A-1 RESIDENTIAL. IT IS THE MIDDLE HOUSE ON A BLOCK OF THREE HOMES BETWEEN HERITAGE LANE AND BOB'S LANE
- THIS PURCHASE COULD MEAN MORE TRAFFIC FOR OUR RESIDENTS; POORER SAFETY CONDITIONS WHEN WALKING STREETS; LOSS OF TAX MONEY TO THE DISTRICT; MUNICIPAL BUILDING USE IN A RESIDENTIAL AREA ETC.
